#### Reminders -

No parking of Trailers, RV's, and Campers on Village Streets from November 1- March 31
Bylaw 2019-10 A bylaw to regulate the parking of Recreational Vehicles and trailers on public highways from November 1 to March 31 inclusive within the Village of Vibank.

The Village is NOT responsible for damages or snow -locked vehicles.

Remember that shoveling or blowing snow onto Village streets is not allowed. Snow from your driveway is to be stored on your property

#### Pets

Pet License renewals are Due in January. The Village of Vibank requires all cats and dogs to be licensed. Licenses are available at the Village Office for \$5.00/ per animal per year. Licensed pets make it easier to find lost owners. Failure to license your pet could result in a fine.
