# Property Information

The unique information identfying your property such as civic address, roll number, etc.



#### Taxable Assessment

The portion of your total assessed value that is taxable based on percentages determined by the Provincial Government.



#### Base Tax

The fiat rate charged to all properties: Base Tax for General Services: \$1650.00 The base tax is a fiat rate tax that pays for basic and universal services such as fire, policing, maintenance and more.



# Mill Rate

Municipal Mill Rate is set by the Town and School Mill Rate is set by the Provincial Government. A mill rate represents the amount of tax payable per \$1000 dollars of taxable assessed value of a property.



#### School Support

The Town is located in the Prairie Valley School Division. As there are no catholic schools in our region, all education taxes collected in White City are allocated as taxes to support public schools.



#### **Municipal Taxes**

The portion of your taxes that: Vibank keeps to fund municipal activities.



#### Total Tax Levy

Your total property tax including the municipal and education portions.



# Discounts

Vibank offers discounts on the municipal portion if taxes are paid prior to August 31, 2024. The discounts section shows which amount you should pay based on the month you are paying your taxes.



#### **Bank Information**

Your property taxes may be paid as part of your mortgage. If they are, the Town will send a copy directly to your bank - if your taxes are not paid by your bank this line will not appear.



#### **Education Taxes**

The portion of your taxes, sent to the Provincial Government, to fund education.



#### Credits and Pre-Payments

If you have made any prepayments or overpaid your taxes in previous years, a credit amount (including applicable discount) will appear here and be deducted from your total tax levy.



# **Penalties**

Taxes are due December 31. Interest of 15% will be charged on all unpaid taxes beginning January 1.
